**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF WYOMISSING, BERKS COUNTY, PENNSYLVANIA, APPOINTING GLENN R. KRAFT OF KRAFT MUNICIPAL GROUP, INC. AS BUILDING CODE OFFICIAL AND APPOINTING KRAFT MUNICIPAL GROUP, INC. AS THIRD PARTY CODE INSPECTOR, PURSUANT TO THE PENNSYLVANIA CONSTRUCTION CODE ACT AND THE UNIFORM CONSTRUCTION CODE, AND APPOINTING KRAFT MUNICIPAL GROUP, INC. AS RESIDENTIAL ZONING OFFICER AND MICHELE BARE AS ALTERNATE RESIDENTIAL ZONING OFFICER PURSUANT TO THE PENNSYLVANIA MUNICIPALITIES PLANNING CODE, EFFECTIVE JANUARY 1, 2026**

WHEREAS, Glenn R. Kraft of Kraft Municipal Group, Inc. was appointed as the Borough of Wyomissing's Building Code Official pursuant to the Pennsylvania Construction Code Act and the Uniform Construction Code, by Resolution No. 2022-30; and

WHEREAS, Kraft Municipal Group, Inc. was appointed as the Borough of Wyomissing's Third Party Code Inspector pursuant to the Pennsylvania Construction Code Act and the Uniform Construction Code, by Resolution No. 2022-30; and

WHEREAS, Kraft Municipal Group, Inc. was appointed as the Borough of Wyomissing's Residential Zoning Officer pursuant to the Pennsylvania Municipalities Planning Code, by Resolution No. 2022-30; and

WHEREAS, Kraft Municipal Group, Inc. was appointed as the Borough of Wyomissing's Alternate Commercial Zoning Officer pursuant to the Pennsylvania Municipalities Planning Code, by Resolution No. 2022-30; and

WHEREAS, the Borough Council of the Borough of Wyomissing wishes Glenn R. Kraft and Kraft Municipal Group, Inc. to continue to serve, effective January 1, 2026, in the same positions to which Glenn R. Kraft and Kraft Municipal Group, Inc. were appointed by Resolution No. 2022-30, except that the Borough Council has appointed Michele Bare, instead of Kraft Municipal Group, Inc., to serve as the Borough of Wyomissing's Alternate Commercial Zoning Officer by Resolution No. 2024-03; and

WHEREAS, the Borough Council of the Borough of Wyomissing wishes to appoint Michele Bare to serve as the Borough of Wyomissing's Alternate Residential Zoning Officer, effective January 1, 2026.

NOW, THEREFORE, BE IT RESOLVED, pursuant to the Pennsylvania Construction Code Act, the Uniform Construction Code, and the Pennsylvania Borough Code, Council for the Borough of Wyomissing hereby reappoints Glenn R. Kraft of Kraft Municipal Group, Inc. as the Building Code Official of the Borough of Wyomissing, effective January 1, 2026.

FURTHER RESOLVED, pursuant to the Pennsylvania Construction Code Act, the Uniform Construction Code, the Pennsylvania Municipalities Planning Code, and the Pennsylvania Borough Code, Council for the Borough of Wyomissing hereby reappoints Kraft Municipal Group, Inc. as the Third Party Code Inspector and Residential Zoning Officer of the Borough of Wyomissing, effective January 1, 2026.

FURTHER RESOLVED, pursuant to the Pennsylvania Municipalities Planning Code, and the Pennsylvania Borough Code, Council for the Borough of Wyomissing hereby appoints Michele Bare as the Alternate Residential Zoning Officer of the Borough of Wyomissing, effective January 1, 2026.

FURTHER RESOLVED, that such appointments shall be at the pleasure of the Borough Council and for an indefinite term in such position.

FURTHER RESOLVED, that the Manager of the Borough of Wyomissing or her designee shall deliver a copy of this Resolution to the appointees.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Borough Council of the Borough of Wyomissing that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.

FURTHER RESOLVED, that except as amended hereby, Resolution No 2022-30 shall remain in full force and effect.

**A RESOLUTION OF THE COUNCIL OF THE BOROUGH OF WYOMISSING, BERKS COUNTY, PENNSYLVANIA, APPOINTING NICK PERILLI OF McCARTHY ENGINEERING ASSOCIATES, INC. AS THE ZONING OFFICER FOR COMMERCIAL ZONING AND MICHELE BARE AS THE ALTERNATE ZONING OFFICER FOR COMMERCIAL ZONING**

WHEREAS, the Pennsylvania Municipalities Planning Code, act of July 31, 1968, as amended, 53 P.S. §§10101 *et seq.*, enables a municipality through its zoning ordinance to regulate the uses of property; and

WHEREAS, pursuant to the authority granted it under the Municipalities Planning Code, Council for the Borough of Wyomissing has enacted a Zoning Ordinance; and

WHEREAS, Section 614 of the Pennsylvania Municipalities Planning Code entitled “Appointment and Powers of Zoning Officer”, 53 P.S. §10614, authorizes a municipality governed by the Code to appoint a zoning officer responsible for the administration and enforcement of the municipality’s zoning ordinance; and

WHEREAS, the Borough of Wyomissing has development throughout the Borough classified as residential and commercial development and construction under the Zoning Ordinance; and

WHEREAS, Council for the Borough of Wyomissing desires to assign duties related to zoning in the Borough including but not limited to questions, permits, and plan reviews depending on the type of development and construction; and

WHEREAS, specifically Council for the Borough of Wyomissing desires to appoint a zoning officer and an alternate zoning officer for commercial development; and

WHEREAS, pursuant to the authority granted it under the Municipalities Planning Code, Council for the Borough of Wyomissing desires to appoint Nick Perilli of McCarthy Engineering Associates, Inc. as Zoning Officer for the Borough of Wyomissing for commercial zoning questions, permits and plan reviews and related duties, and to appoint Michele Bare as alternate Zoning Officer for the Borough of Wyomissing for commercial zoning questions, permits and plan reviews and related duties.

NOW, THEREFORE, BE IT RESOLVED, pursuant to Section 614 of the Pennsylvania Municipalities Planning Code entitled “Appointment and Powers of Zoning Officer”, 53 P.S.

§10614, Council for the Borough of Wyomissing hereby appoints Nick Perilli of McCarthy Engineering Associates, Inc. as Zoning Officer for the Borough of Wyomissing for commercial zoning questions, permits and plan reviews and related duties, and hereby appoints Michele Bare as alternate Zoning Officer for the Borough of Wyomissing for commercial zoning questions, permits and plan reviews and related duties, whenever requested by the Borough Zoning Office to act as such Alternate Commercial Zoning Officer.

FURTHER RESOLVED, that such appointment shall be at the pleasure of the Borough Council and for an indefinite term in such position.

FURTHER RESOLVED, that the Manager of the Borough of Wyomissing or her designee shall deliver a copy of this Resolution to the appointees.

FURTHER RESOLVED, that this Resolution shall take effect immediately, or as soon as legally permissible thereafter.

FURTHER RESOLVED, that if any provision, sentence, clause, section, or part of this Resolution shall for any reason be found to be unconstitutional, illegal or invalid, such determination shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Resolution, and it is hereby declared to be the intent of the Borough Council of the Borough of Wyomissing that this Resolution would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section, or part not been included herein.
