

Total Monthly Service Area Call Volume





Tower Health - Reading Hospital



RE: Covered Vehicle

NAME,

I am writing to inform you of concerns and complaints received regarding a vehicle, believed to be owned by you, that has been parked on a public street, STREET NAME, for an extended period while covered. While we fully recognize that a legally registered, insured, inspected, and operable vehicle may be lawfully parked on a public street, we also have an obligation to ensure that all vehicles remain in compliance with applicable Borough ordinances and the Pennsylvania Vehicle Code.

At this time, the vehicle remains covered, which prevents our police department from verifying the validity of its registration and inspection. This creates challenges in ensuring public safety and regulatory compliance. Based on the visible shape, the vehicle appears to be BASIC VEHICLE DESCRIPTION. Our records indicate that you are the registered owner of a VEHICLE YEAR/MAKE/MODEL with Pennsylvania registration REGISTRATION #, which is currently valid through the end of MONTH/YEAR.

However, without visibility of the registration and inspection stickers, we cannot confirm whether this vehicle is the one in question or determine its inspection status. I recognize that an officer lifting the vehicle cover to obtain this information could be considered an unlawful search by a court of record, we are therefore limited in our ability to verify compliance through usual means.

We kindly ask that you take the following steps:

- Ensure the vehicle remains legally registered, insured, inspected, and operable.
- Consider relocating the vehicle to your private driveway, or
- Adjust or partially remove the cover to make inspection and registration stickers visible from the street.

If this issue persists and we continue to receive complaints without a practical way to verify compliance, the Borough may be compelled to explore legislation prohibiting covered vehicles from being parked on public streets for extended periods.

We appreciate your understanding and cooperation as we work to uphold the safety and quality of life in our community. If you have any questions or would like to discuss this matter further, please do not hesitate to contact me directly.
