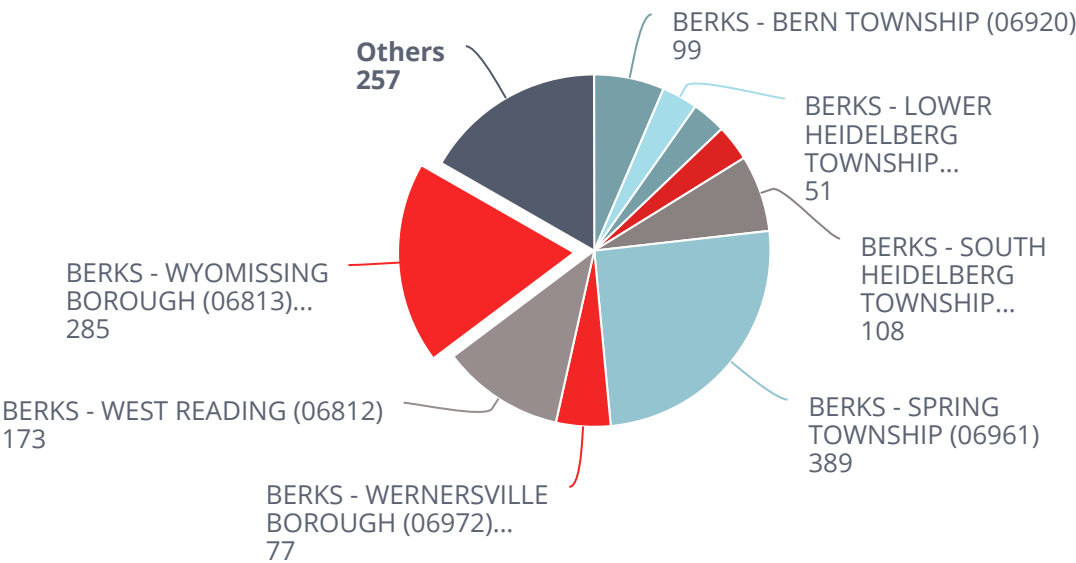

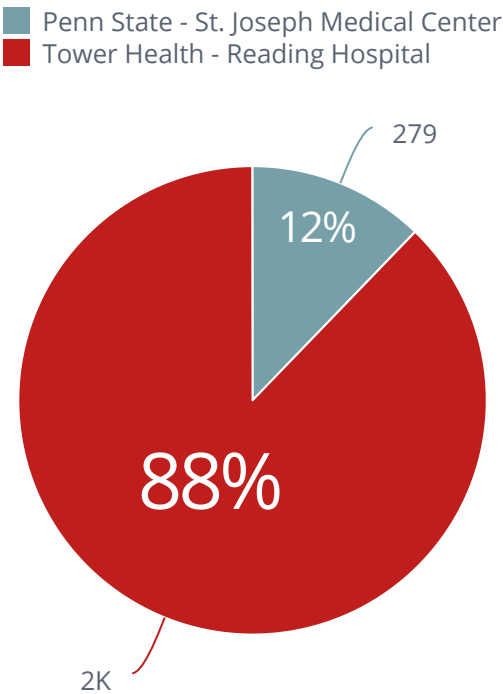
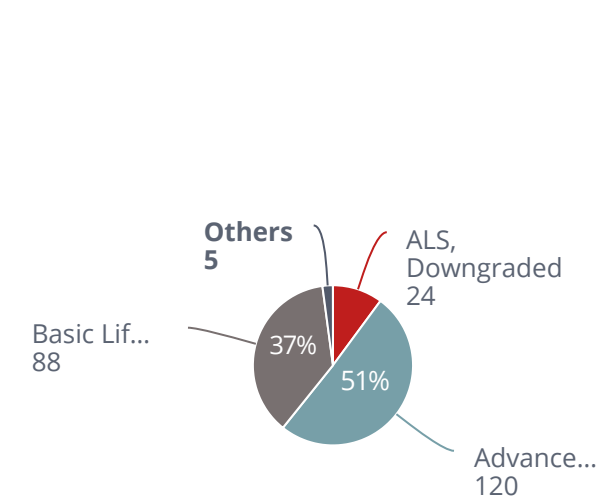

Yearly Breakdown by Hospital Destination



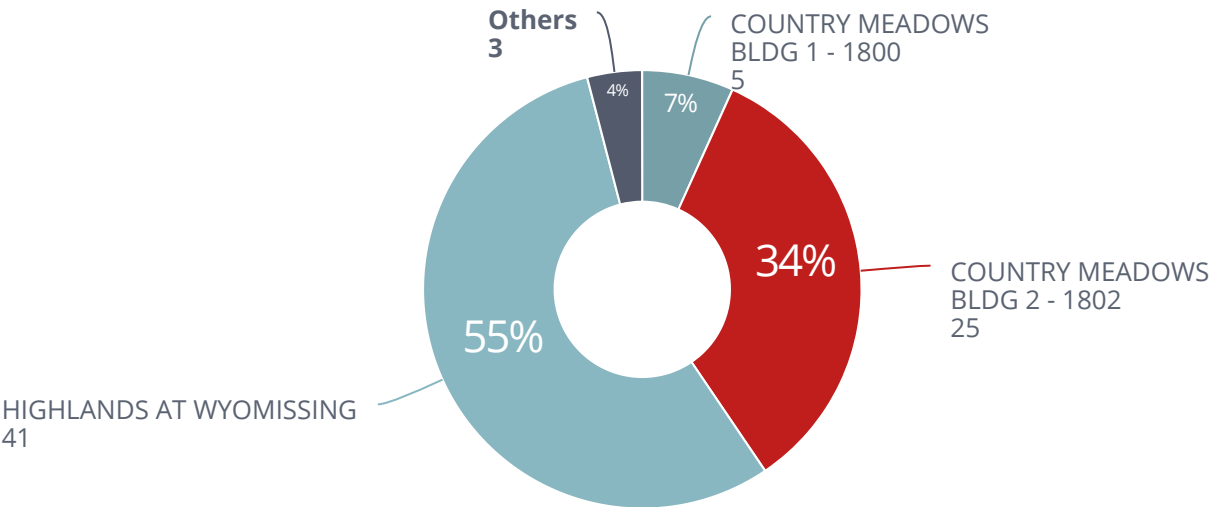

In our role as Borough Traffic Engineer, TPD has reviewed the Penn Avenue on-street parking located in the vicinity of the U.S. Post Office and the Bausman Memorial Church. The following is our feedback and recommendations:

- Even though Penn Avenue is a state-maintained roadway, the Borough has the authority to restrict parking. The days, hours, etc. of parking restrictions are also fully in the Borough's purview.
- The Borough Code allows the Mayor to implement immediate restrictions, which would then need to be followed by an update to Section 402 of the Borough's parking ordinance to include the southside of Penn Avenue. If implemented, the restriction should be from S. Trent Avenue to Belmont Avenue.
- If the Borough chooses to prohibit parking on the southside of Penn Avenue, we recommend the following:
 - Since the Post Office is closed on Sundays, the Borough could elect to restrict parking only Monday through Saturday. For the posting of the parking restriction, we recommend installing the following signs:
 - R7-3-1 No Parking Symbol with EXCEPT SUNDAYS, 12"x18" and a R7-301 No Parking Arrow Plaque, 6"x12;
 - Install at Belmont Avenue with a right pointing arrow.
 - Install opposite the Post Office entrance with a double pointing arrow.
 - Install at S. Trent Avenue with a left pointing arrow.

- To provide additional parking for Post Office patrons, the Borough could consider shifting the centerline of Bern Road between N. Trent Avenue and George Avenue to allow on-street parking on the southside of the street adjacent to the Post Office. It appears that the existing centerline is already shifted between N. Trent Avenue and Hobart Avenue and parking (2 hour) is permitted today on the southside in this section. This would just be an extension of the existing conditions.
 - If centerline striping changes are implemented on Bern Road, the Borough should consider installing additional pavement markings at the intersection of Penn Avenue, Bern Road, and George Avenue to better define the intersection and travel lanes.
- If feasible, the Borough could consider facilitating conversations to allow Post Office employees to park in The Works parking lot to provide additional customer parking on the Post Office site.



Mayor, Honorable Borough Council Members and Respected Citizens of the Borough:

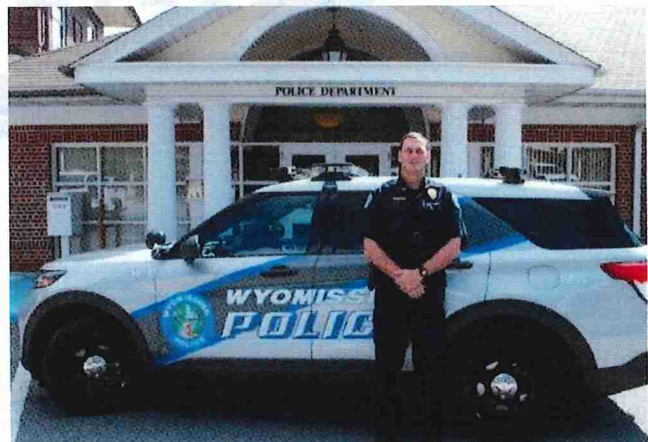

WYOMISSING BOROUGH POLICE 2024 END-OF-YEAR REPORT

EXECUTIVE SUMMARY

- 8,909 total calls were handled in 2024, which is a increase of 1,395 from 2023. 2024 was the busiest year on record for the police department. Traffic violations, Alarms and Non-Reportable Accidents round out the top three incident types in 2024.
- A total of 376 adults and juveniles were arrested in 2024, a decrease of 92 from 2023. There were a total of 476 incidents that involved UCR reportable offenses, those cleared by arrest or exceptional means gave the department a respectable 77% clearance rate.
- Naloxone was administered four (4) times in 2024 by Wyomissing Police Officers to persons overdosing on opioids. All individuals survived their incidents.
- A combined total of 3,632 traffic citations, parking tickets and warnings were issued. Officers continue to take an incident number for all traffic violations to better track the total number of stops being made and their outcome. A breakdown of those stopped can be found within this report.
- There were a total of 711 crashes in the Borough. 411 of the 711 crashes were non-reportable and 193 were reportable. We were also fortunate to have registered zero (0) fatalities.
- Police Officers patrolled a total of 127,125 miles and consumed 13,371 gallons of fuel.
- The Police Department brought in \$234,592.05 from arrests, fine monies, requests for reports, billing for excess alarms, and overtime reimbursements from grant money. Department expenditures totaled \$3,270,164.00.

POLICE OFFICERS

The Department supervisory staff at year's end consisted of myself, Chief John Phillips, Lieutenant Paul Baur, Sergeant Peter Purcell, Sergeant Richard Karstien, Sergeant Scott Schaeffer, Sergeant Sean Engelman and Detective Sergeant Kevin Quinter. The Mayor of Wyomissing continues to be the Honorable Frederick C. Levering.

The 2024 roster ended with 22 full-time officers. Below is a list of those officers:

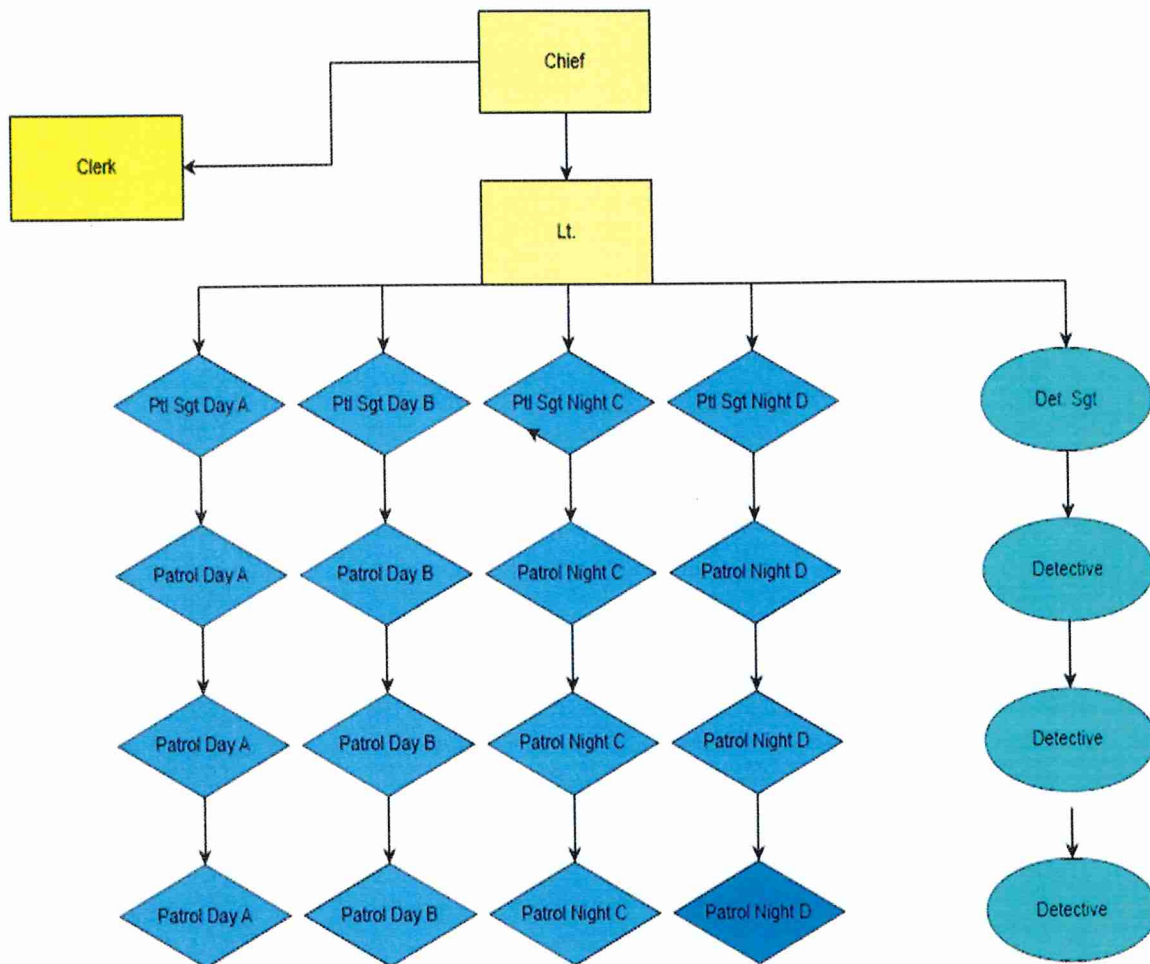
The schedule for patrol officers consists of four (4) squads, two (2) assigned to day shift and two (2) assigned to night shift. The shifts consisted of two (2) twelve-hour stints, the squads working 7a.m. to 7p.m. and 7p.m. to 7a.m. Sergeants Purcell, Karstien, Schaeffer, and Engelman support the basic schedule and supervise the activities of the officers on their squad in addition to other administrative functions they perform.

The Investigative Unit is supervised by Detective Sergeant Kevin Quinter and consists of Detectives Joseph Klatt, Matthew Cavallo and Ryan Solecki. The criminal investigators normally work 8:00 a.m. to 4:30 p.m. and 11:30 a.m. to 8:00 p.m. but are subject to change dependent upon the types and patterns of crimes being committed.

SYSTEMS ANALYST

Christopher Sam continues to provide much needed clerical and data entry help during the week, 7:30a.m. – 3:30p.m. Chris also provides relief in performing many jobs that would take an officer off the street. For instance, if a police vehicle needs to be taken for service, he can transport the cars to and from the garage. State rules and regulations mandate that certain police areas remain off limits. Chris is on hand to oversee contractors when officers are not inside the building. If not for his services, our officers would be spending a great deal more time in the office and incurring unnecessary overtime.

SPECIALIZED SERVICES

The Police Department can boast of numerous officers who have an abundance of talent and expertise in specialized fields. These specialized fields are as follows: Bicycle Patrol, Criminal Investigations, Crime Prevention, Range Master, Evidence Technicians, Less Lethal Instructors, Active Shooter response (for law enforcement and the public), MCSAP, Crash Reconstruction, Drug Recognition Expert, Defensive Tactics, and the Youth Aid Panel.

- Sergeant Purcell is part of the District Attorney Accident reconstruction Task Force.
- Detective Sergeant Kevin Quinter, Detective Joe Klatt, and Detective Matt Cavallo are part of the Narcotics Task Force.
- All Detectives are cross-sworn as County Detectives.
- Detective Cavallo is part of the Alcohol Tobacco and Firearms Task Force.
- Four (4) officers are assigned to the Berks County Emergency Response Team (BCERT). Chief Phillips is the commander, two (2) are assigned to the tactical element and one (1) is a negotiator. BCERT is a group of highly trained officers that deal with situations beyond that of a normal officer.
- Sergeant Engelman and Officer Moser are Defensive Tactics and Handcuffing instructors.
- Sgt. Engelman and Officers Moser, Hurlbrink, Moris and Bird are Field Training Officers who train newly hired officers.
- Sgt. Karstien and Officer Estevez are certified to teach CPR/First Aid.
- Officers Borman-Parker and Moris are MCSAP qualified to inspect commercial motor vehicles.
- Sergeant Karstien, Detective Klatt and Detective Cavallo are Firearms Instructors.
- Detective Sergeant Quinter and Detective Klatt are members of the Berks County Human Trafficking Taskforce.

PROBLEM-ORIENTED POLICING

Problem-Oriented Policing is part of our Community Policing initiative. We have been engaged in POP since 2000, in response to problems that appeared in the Borough. Problem-Oriented Policing acknowledges that problems exist, and we try to solve them in a proactive manner rather than simply responding to incidents. This is a process where the separate squads develop and implement plans to combat problems at the source. Over 823 hours were utilized in problem solving patrols last year. Hotels and nightclubs and their residual effect on the Borough account for some of the time spent. Not included in these hours, but associated, are foot patrols, both day and nights, in areas where we see spikes in incidents.

TRAINING

Training is an important part of the Wyomissing Police Department. Training is viewed not as time and money spent, but as invested in preparing our officers to perform effectively and professionally. It also helps to reduce the exposure of the Borough to liability through proper training. Over 3,786 hours were invested in keeping our officers highly trained and well-rounded.

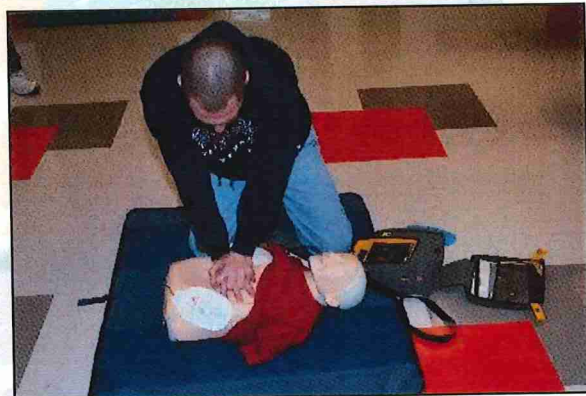


An additional 640 hours of training is attributed to our BCERT team members who attend mandatory monthly training.

We also conduct our own, active shooter training, scenario-based exercises, less lethal munition certification, firearms, and First Aid/CPR certification. Officers must also complete 12 hours of mandatory in-service training. This training consists of 4 separate courses of instruction approved by the Pa. State Police and the Municipal Police Officers Training Commission. This year we continued training our officers in defensive tactics so that they are better equipped at dealing with those individuals that are resistant to arrest so that both they and the officer are less likely to receive serious injuries as a result of that encounter.



In 2024 we continued our partnership with Lexipol, a public safety policy management company. Lexipol runs PoliceOne Academy, a training platform for law enforcement agencies. Each month, officers conduct two (2) hours of online training on various topics. The department policies have also been placed on this platform which helps to ensure officers remain current with policy.



COMMUNITY POLICING AND PROGRAMS

Community policing emphasizes the establishment of a working partnership between the police and community to reduce crime and enhance security. The Police Department continues to work towards that goal by offering numerous and varied community programs and presentations.



These programs are supervised by Chief Phillips and presented by crime prevention Officers Shannon Barr and Maria Figueroa-Medina, and Sam Bryant. Other officers are often asked to participate depending upon the topic.

In 2024, officers were able to participate in 26 activities throughout the year that included Active Threat training, Wyomissing Public Library carnival, Movie in the Park, Coffee with a Cop, Spooky Hollow and Shop with a Cop to name a few.



A yearly favorite activity is Shop with a Cop. Shop with a Cop is a program that the Wyomissing Police partners with Crime Alert Berks County and the Central Berks Regional Police to shop for Christmas presents with less fortunate children.

CITIZEN POLICE ACADEMY

In 2024, we once again partnered with the West Reading and Spring Township Police Departments to run a Citizen Police Academy from October to November. The Citizen Police Academy began in 2009 but stopped in 2020 because of the Covid-19 pandemic. All participants enjoy the program, and the entire experience is a give and take of information between police and the public.

The academy is designed with three goals: to educate citizens to be more proactive in protecting their community; to provide insight into the operations of the police departments; and to build a trusting and understanding relationship between residents and their police.

Topics of the academy included traffic enforcement, pursuits, forensics, criminal investigations, narcotics education and the court system. This has been a very successful program, and classes fill up as quickly as we advertise.

WYOMISSING AREA SCHOOL DISTRICT

Our department continues to have a great working relationship with both the Wyomissing Hills Elementary School and the Wyomissing Area Junior/Senior High School. When available, Officers are present for both student drop-off and pick-up. Additionally, Officers do regular walk-throughs of both schools. The school district does have its own School Resource Officer who handles most minor issues. Any criminal incident of a misdemeanor level or higher is still handled by our department.

SPECIAL SERVICES UNIT

In 1994 the department formed the Special Services Unit, it completed its 30th year of service in 2024. The Special Services unit responded to crime scenes where incidents required multiple pieces of equipment and extended time duration at the crime scene.



Today many people have come to expect that a police department will have a forensic unit. Not only does a jury expect to see a forensic investigation into a crime, but the District Attorneys who prosecute the case do as well.

The unit spent almost 40 hours throughout the year processing 26 crime scenes, evidence at the hall in the processing room and completing all

associated reports. The average time spent on an incident was approximately 1.5 hours. The decrease in crime that will be spoken about later in this report has reduced the number of incidents in which an evidence technician is needed.

The team consists of Sergeant Scott Schaeffer, Officer Bryan McIntyre, Officer Alex Bird, Officer Maria Figueroa-Medina and Officer Brandon Moris.

CAMERA SYSTEMS

The department previously implemented the use of both in-car cameras as well as body-worn cameras (BWC's). Each of the marked patrol cars are equipped with three (3) cameras: front view, wide-angle front view and a camera pointed into the prisoner compartment. Officers assigned to patrol sign out a BWC for each of their shifts and the camera is activated for each call. For 2024, the department recorded 18,998 events. The camera footage from those events continues to prove to be an invaluable asset for both court and training purposes.



The Borough can also boast of having a robust License Plate Reader (LPR) program throughout the borough. The LPR's assist law enforcement by providing a pointer system that may help identify vehicles associated with suspects, witnesses, victims, and to develop exculpatory information that assists in focusing investigative resources. There are numerous static cameras strategically positioned throughout the

borough as well as two patrol vehicles having cameras affixed to them. The cameras were utilized a total of 128 times throughout 2024 to assist officers in investigations.

CRIME AND CALLS FOR SERVICE

The Police Department ended 2024 with 8,909 total calls for police response. This is an increase of 1,395 calls from the 7,514 calls recorded in 2023 and is the busiest year on record for the department.

Criminal offenses investigated were down this year as we investigated 476 criminal offenses in 2024, compared to 634 in 2023, a decrease of approximately 25%. The Wyomissing Police Department differentiates between calls for service and criminal offenses. Calls for Service are those incidents that do not involve a crime but require police intervention. Examples of such calls could be accidents, animal complaints or other quality of life issues.

Generally, theft continues to be the most prevalent crime committed in the Borough. During the year we investigated two (2) incidents of robbery and twenty-three (23) varying types of assault.

Frauds (31) are generally not violent but are extremely difficult to investigate and prosecute. Using the “dark web” offenders can scam people out of thousands of dollars with a few simple clicks. Most times, the suspects are not even in the United States. ID theft and crimes committed via computer are becoming the norm. We are becoming more dependent on computer-savvy police officers, as the public continues to fall prey to computer scams.

UNIFORM CRIME REPORT

The Uniform Crime Reporting (UCR) Program was created in 1929 by the International Association of Chiefs of Police and is maintained by the FBI. The FBI collects, publishes, and records crime statistics. Local departments collect their data and transmit it to each individual state. The States then forward the information to the FBI. See appendix A for complete UCR report.

The Wyomissing Police Department is an investigative department. Instead of simply taking a report, our officers and detectives put more effort into solving the crimes. **The department's clearance rate remains at a high rate of 77%.** In 2019, the national average for clearing violent crimes was approximately 45%, for property crimes it was approximately 17%. The UCR is divided into two parts. Part I offenses are Murder, Rape, Robbery, Assault, Burglary, Larceny, Motor Vehicle Theft and Arson. All other crimes would be considered Part II offenses.

The following table shows the number of crimes committed and compared over a twenty-year period from 2005 to 2024. Criminal offenses in 2024 decreased from 2023 approximately 25%, a trend we hope to see continue.

The calls for service remain at a relatively high level in comparison to criminal events. Most police service responses are false alarm activations, accidents, and disorderly subjects. Another reason for high amounts of service calls is that the public often finds it easier to call police to assist them in non-police matters because they do not know whom else to call.

We continue to respond to civil issues and neighbor disputes as service is important in a community. The department is very aware of the "Broken Window" theory, and we firmly believe that if you take care of the small things, the big things take care of themselves. This seems to hold true as we continue to concentrate on our service response and aggressive patrol operations as evidenced by our offenses going down.

ARRESTS

In total, 358 adults were arrested and 18 juveniles, for a combined total of **376** people. That figure does not include those people cited for traffic violations.

Most juvenile crimes are thefts, liquor violations and disorderly conduct. Juveniles (10-17) technically are not arrested but referred to Juvenile Court for disposition. We also continue our partnership with the Berks County Youth Aid Panel. Youths who run afoul of the law are given the opportunity to avoid a juvenile arrest if they agree to terms of a Community Panel who balances the needs of the juvenile with the needs for restorative justice. In 2024, twenty-one (21) individuals were referred to the program, this number is not part of the total juveniles arrested. Officers Shannon Barr and Sam Bryant continued as our department liaisons with the Youth Aid Panel.

The number of persons arrested whose race was white totaled 271 or 76% of those arrested. Those whose race was black totaled 90 or 24% of those arrested.

Persons arrested whose ethnic origin is Hispanic totaled 150, or 40% of those arrested. Non-Hispanic ethnic origins arrests were 226, which is 60% of all arrests.

Arrests by gender show 254 males arrested as compared to 122 females. In the above table, males account for 67% of all people arrested and females account for 32% of all people arrested in 2024.

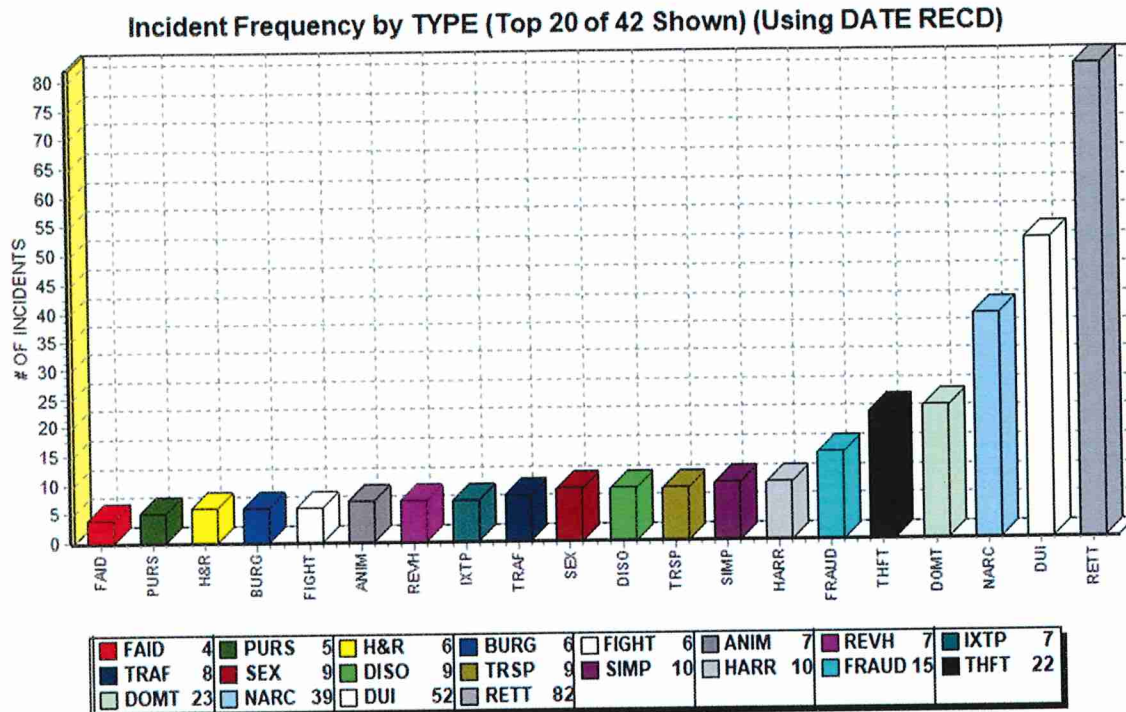
ARRESTS / AGE

Not surprising, the largest number of adults arrested are between the ages of 30 - 34, roughly 17%. 62% of all adults arrested are under the age of forty (40), indicating that crime is a young persons' game. However, we still encounter a small number of older criminals. In 2024, we arrested sixty-two (62) age 50 or older. The table below indicates the number of adults arrested by age group and the percentage that group represents of adults arrested.

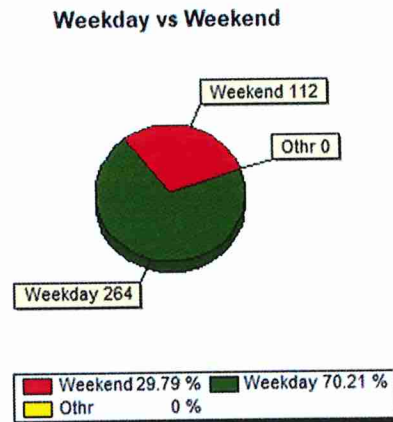
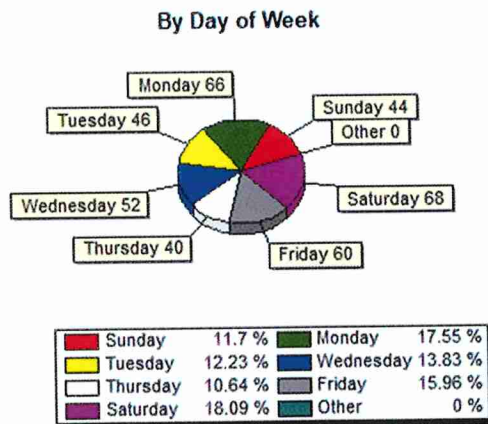

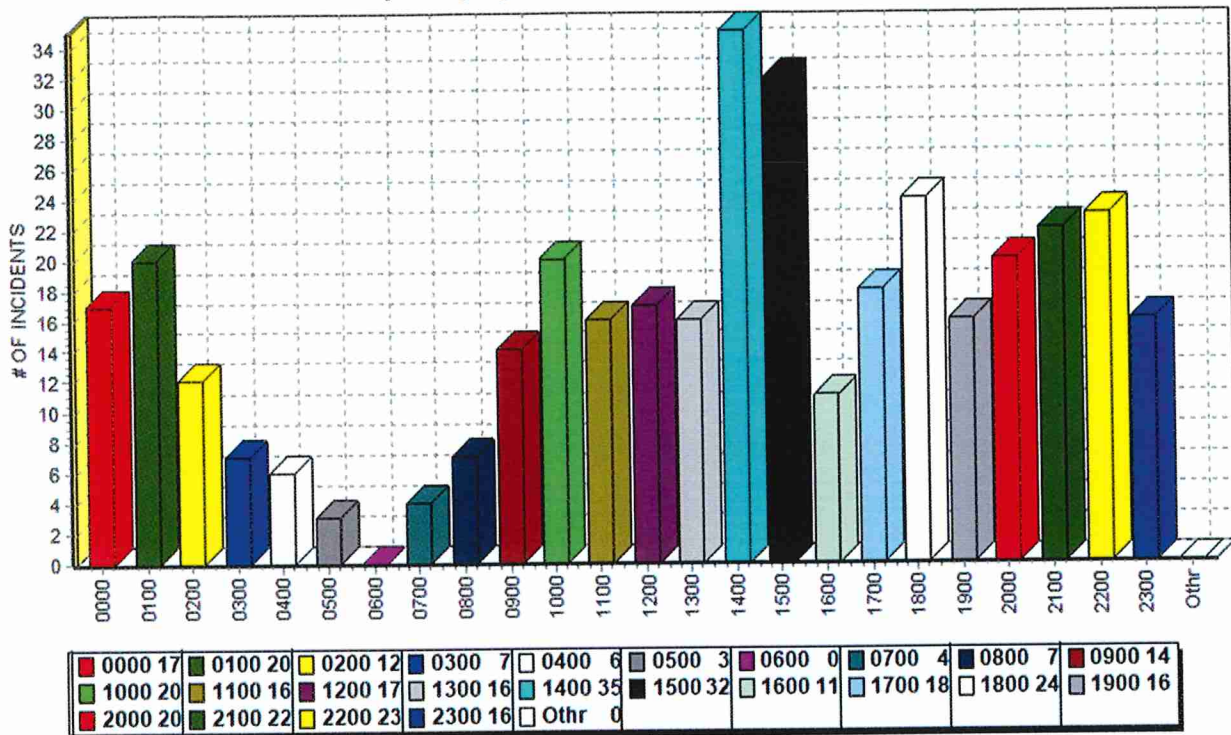

SUCCESSFUL PROSECUTION

On May 6, 2019, the Wyomissing Police Department began an investigation into a homicide in the Greenwood Mall section of the borough. After approximately two years of an intensive investigation by this agency and the Berks County Detectives, Jarren Walker was arrested. In October of 2024, Walker was tried for the death of Nail Salamov. After a weeklong trial, Walker was found guilty on all charges. The successful prosecution of Walker for homicide was marked by compelling evidence, including eyewitness testimony and forensic analysis, leading to a conviction. The jury found the defendant guilty after deliberating on the case, which presented a clear motive and established cause of death beyond reasonable doubt. The thorough investigation, supported by the seamless cooperation between local law enforcement, played a crucial role in gathering the key evidence that ultimately secured the conviction.

SUBSTANCE ABUSE

All too often crimes have the underlying contributing factor of drugs or alcohol usage. To assist the department, special DUI and liquor enforcement patrols are grant funded, allowing us to be proactive without taking away officers from normal patrol duties. The Police Department overall takes a proactive approach to drug and alcohol involved offenses.

Detective Sergeant Quinter continued his 12th year as a Drug Recognition Expert. In those cases of DUI where no alcohol is present, he can determine if drug usage is the underlying cause for the DUI behavior.

The following table shows a comparison of our substance abuse incidents over a five (5) year period. Our greatest decrease was in narcotic incidents, which can be partially attributed to pro-active policing throughout the borough.

Officers continue to respond to opioid events. All officers have been trained in the use of Naloxone, to save lives of users who overdose on opioids. We also carry it for our own safety as heroin is being cut with fentanyl and we may inadvertently encounter and be exposed to the substance. In 2024 we responded on four (4) occasions where Naloxone was administered by an officer. Fortunately, all of the individuals administered Naloxone by a Wyomissing Police Officer survived.

USE OF FORCE

A Wyomissing Officer must complete a Use of Force Report whenever they:

1. Discharge their weapon(s) in the performance of their duty except when training, recreational purposes or the destruction of an animal.
2. Takes any action that either results in, or is alleged to have resulted in, any injury or death to another person.
3. Uses physical force on another person at or above Level 5 force as outlined in department policies and procedures.
4. Discharges chemical agents(s) or a Taser against another person.

In 2024 no incidents required the completion of a Use of Force Report by our officers.

OFFICER TIME ANALYSIS

Officers were available for service a total of 45,020 hours throughout 2024. The following table shows the percentage of time spent by all officers in their various functions throughout 2024.

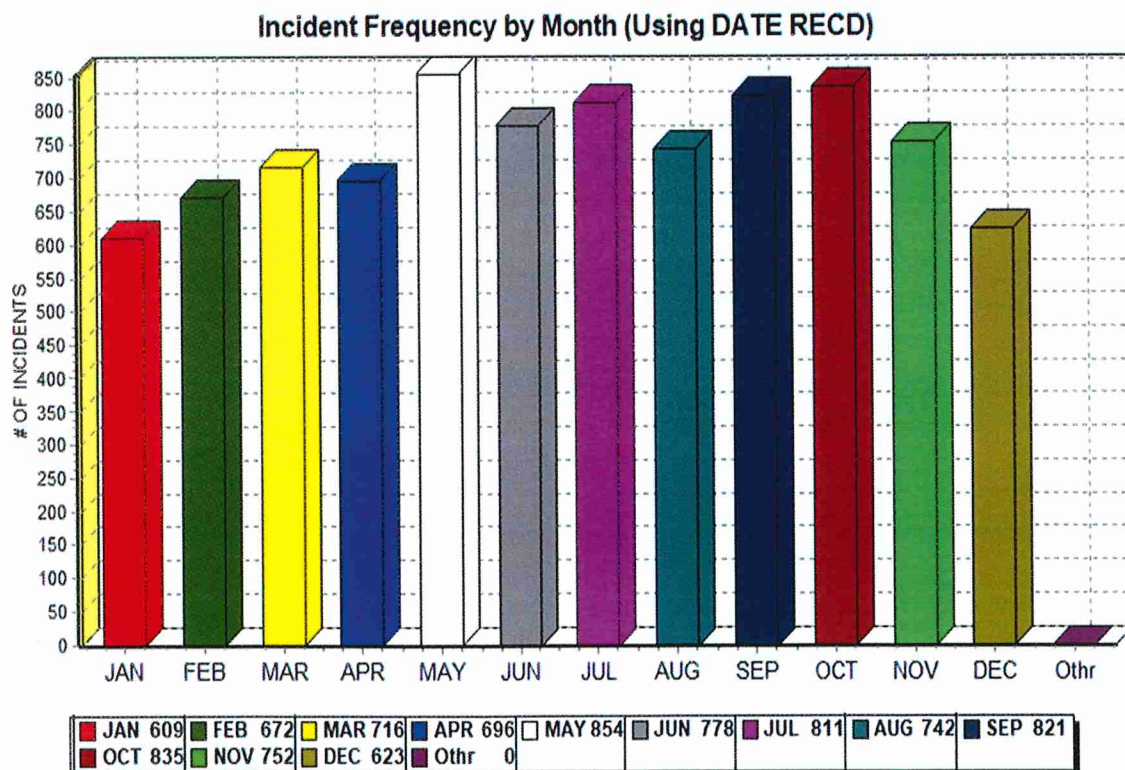

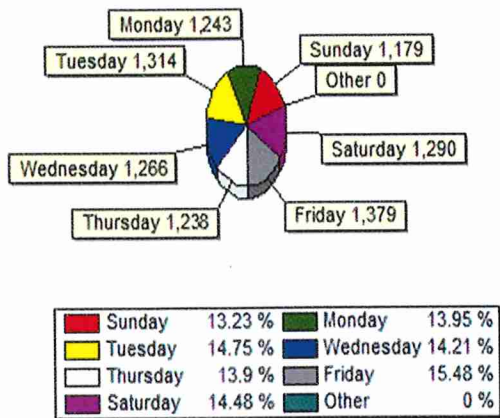
INCIDENT FREQUENCY

The average number of recorded calls per month was 742 incidents. May was the busiest at 854 incidents, and January at 609 calls was the lowest. Realistically, the differences in call volume across the months are minimal, and most likely is attributable to environmental conditions.

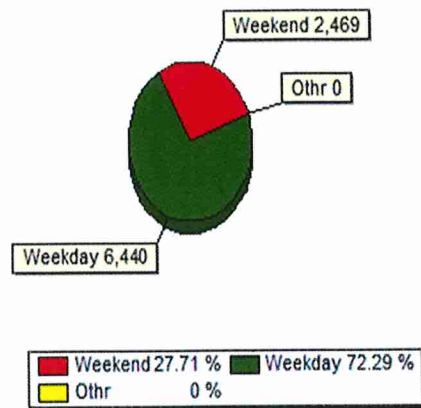
Weekends (Sat. /Sun.) account for almost 28% of our calls while weekdays account for 72%. The busiest day of the week was Friday with 1,379 calls, about 15%. The least busy day was Sunday at 1,179 incidents. Like monthly calls, the difference in call volume across the days of the week is insignificant. Every day is busy.



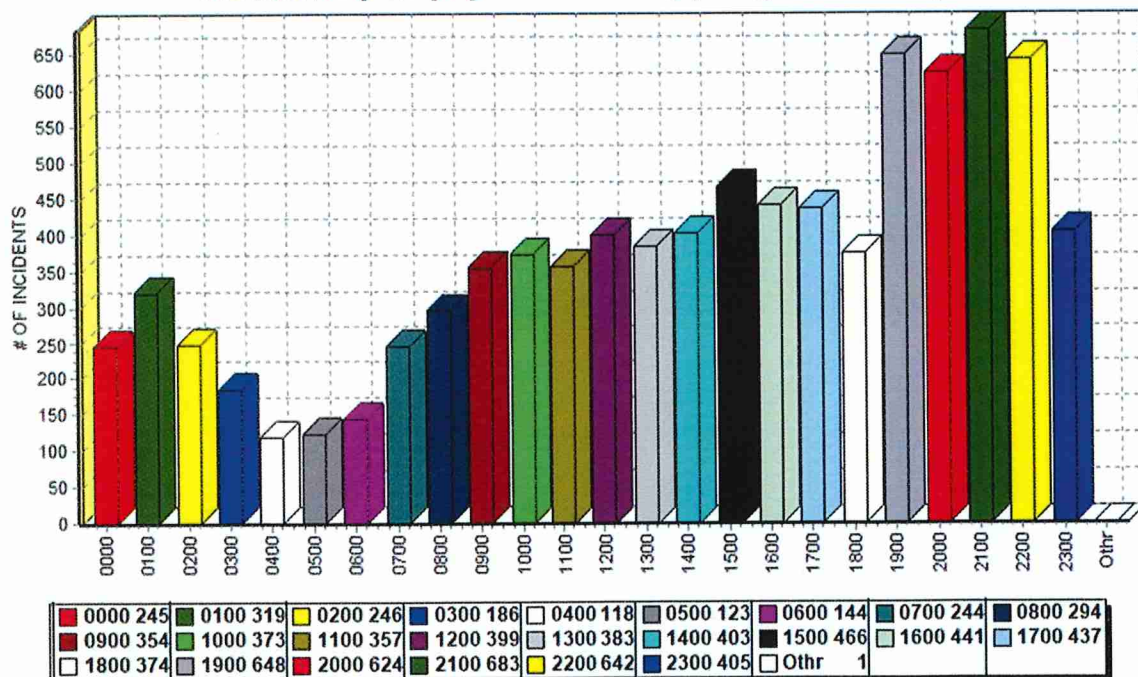
By Day of Week

The above table shows at what time of the day officers handle incidents. The 9:00 pm hour was the busiest with 683 incidents handled, while the 4:00 am hour was the least busy with 118 incidents handled.

HOTEL INCIDENTS

The Borough is unique in that for a small municipality we have eight (8) hotels in the area, however the Inn at Reading closed in 2024 bringing the total to seven (7) by years end. Thousands of people visit and stay at hotels in the Borough, and as a result in 2024 they generated 301 calls, down from 401 calls in 2023. Insofar as criminal activity is concerned, of the 301 calls, 30 were actual criminal events, or 9.9% of the hotel calls.

The department continues to seek proactive alternatives as our hotels have seen an increase in a wide range of incidents. As a result, we have dedicated a Detective to function as a liaison with all our hotels. However, current reactive arrest measures are a priority.

Detective Klatt is assigned to investigate reports of human trafficking, narcotics and weapons violations. Throughout the year, special details have been conducted at various hotels focusing on individuals using the internet to solicit sex, including from underage individuals.

The below table shows the total number of responses to each hotel, and the number of criminal offenses. The Days Inn accounts by far for the greatest number of calls to a hotel.

TRAFFIC ENFORCEMENT AND VEHICLE ACCIDENTS

Traffic stops and parking violations are among the most commonly and widely employed police actions. More citizens meet police at these times than at any other, and their opinion of police operations is often formed through these encounters. The main reason officers conduct traffic stops and write parking tickets is to enhance public safety by encouraging voluntary compliance with traffic laws. The goal is to reduce accidents and injuries on our roadways and to keep the heavy volumes of traffic moving efficiently and safely through the Borough.

We receive residents' complaints of traffic infractions on a routine basis. In response, we conduct special traffic observation details to determine if any additional targeted traffic enforcement is warranted in those areas. It is ironic that upon enforcement we find those committing violations often live in the same neighborhood.

The following table shows our accident totals over a five-year period in the Borough. Overall, we responded to 711 accidents in 2024, virtually the same amount as 2023.

The number of reportable accidents handled in 2024 was down from 2023, but the number of non-reportable accidents was up. Reportable accidents are those in which someone is injured and taken by ambulance to a hospital, or in which a vehicle needs towing due to damage making it inoperable. Non-Reportable accidents are those "fender benders" where there is no one injured, and no vehicle requires towing.

VIOLATIONS

Roadway traffic congestion is a major source of frustration for travelers. Add that to the fact that everyone is in a hurry, and you have the ingredients for road rage and traffic violations. The lack of additional road capacity as populations of licensed drivers, cars, trucks, and miles traveled increase creates aggressive and unsafe drivers. Our officers are required to perform traffic observation checks throughout the Borough on each shift.

Not everyone receives a citation; in 2024 officers issued 1,638 warnings compared to 1,921 citations. Manpower permitting, we will set up special traffic details with some of those focusing on large truck enforcement and truck weighing details.

Incident numbers are generated for every traffic stop to better account for the number of stops conducted by our officers, the reasons for the stop and the outcome. A total of 2,533 traffic violation incidents were taken, this number does not include those stops that ended in an arrest of some type.

The below tables indicate the number citations, warnings, and parking tickets issued, as well as the sex, race and ethnicity of those stopped.

Two (2) tools we used during the year were a speed-timing trailer, and portable speed sign/counter-recording device. Both machines enable us to check speeds on streets and respond accordingly with directed enforcement. The devices also perform-vehicle counts so we can determine traffic volumes on certain streets and gain accurate counts of speeds rather than relying on public observations where “the cars are flying.” The portable speed signs alert motorists to their speeds. It seems to be working, and it has been requested by many residents to have it installed on their streets.

SPECIAL PATROL AREAS

Wyomissing Borough is unique in that we have a large portion of the Borough dedicated to commercial/retail businesses as well as residential areas consisting of apartment complexes and senior living centers. Both areas account for approximately 30% of all our calls for service. Calls in both our business and residential districts were down this year.

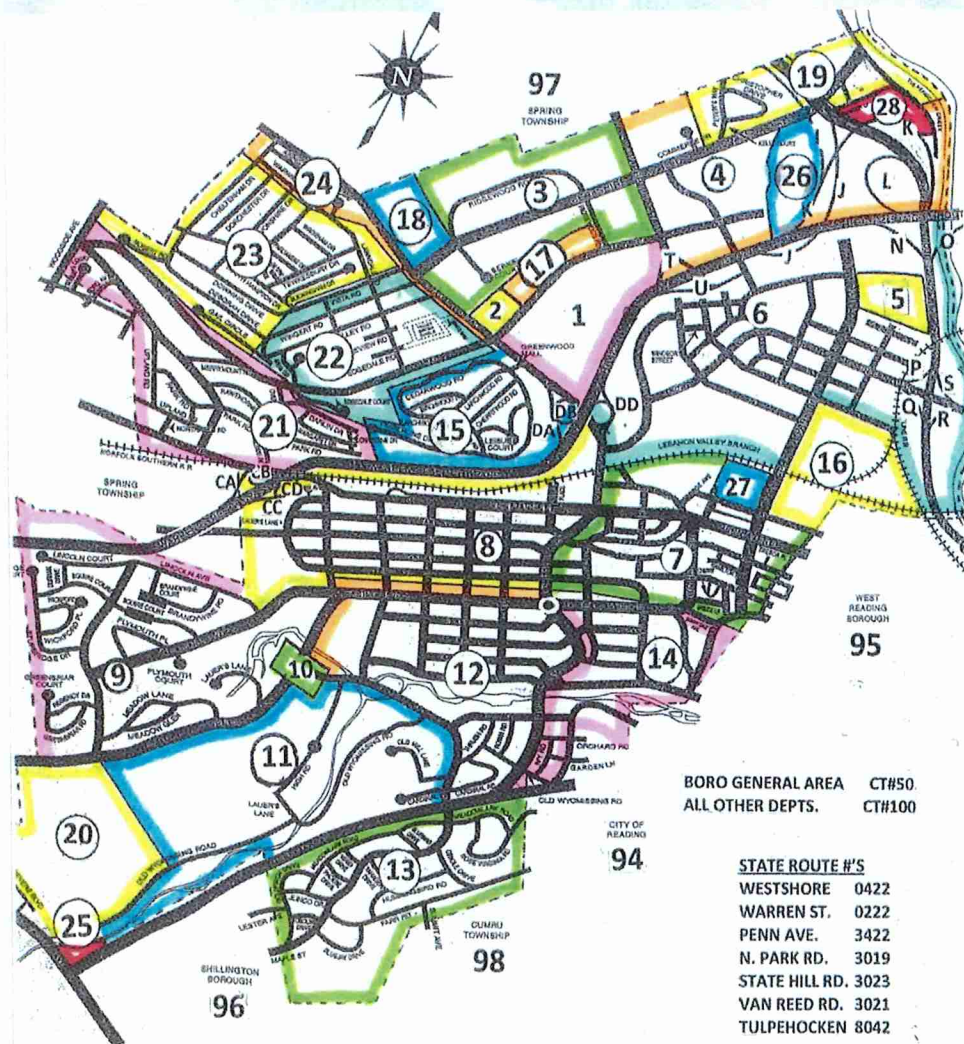

VEHICLES AND MILEAGE

Patrol of the Borough was conducted by utilizing both marked and unmarked vehicles. In addition to patrolling the streets, we patrol the Borough Parkland System. The Ford Interceptor SUV vehicles have become the workhorse of police departments across the country, as well as our patrol unit. The Special Services van continues to provide support as an emergency command post and mobile crime lab.

Overall, during 2024 our police cars covered 127,125 miles and used approximately 13,371 gallons of fuel. Dependent upon vehicle miles and normal wear and tear, cars are taken out of service and replaced on a rotating basis.

During 2024 we were called upon to assist other police agencies. Most of our assists are to our neighboring police departments of West Reading and Spring Township. However, we often are called to assist the City of Reading, Cumru Township, and Shillington Borough Police Departments. Additionally, we also work together on various incidents with the FBI, DEA, ATF, HSI and the DA's Office. The first table shows the number of assists to other agencies during 2024, the second table shows the assists over a five-year period.

SPECIAL DETAILS

Our officers are often called upon to perform services for private and/or public events that go beyond our normal operating capabilities. In these instances, we need to specifically assign an officer(s) to the detail and then the requesting party is invoiced for our time. This way the taxpayer is not footing the bill for specialized police service.

There are other times when officers are called upon to perform specialized services and the Borough is not reimbursed. An example would be the Memorial Day and Fourth of July Parades, when officers must direct traffic and control the streets during the parade.

In 2024 we conducted 77 special details throughout the Borough. Requests for road runs are extremely labor intensive and continue to be requested. The Wyomissing Area High School has also cut back on police presence at sporting events since they hired their own Police Officer.

REVENUES & EXPENDITURES

Revenues:

During 2024 the police department collected fine money generated from criminal arrests, traffic, and parking tickets. The department also collects monies from reports that are requested by outside agencies. Usually these are insurance companies requesting accident reports. The department also generates revenue for invoices regarding excess burglar alarms. Also, the police department received grant money which reimbursed the borough for pro-active overtime enforcement details.

The below table shows those revenues generated by the police department. The District Justice office collects local fines. The County and State collect fines and restitution from criminal cases. Fees for false alarms are invoiced quarterly. Overall, the police department accounted for **\$234,592.05** in revenue.

Expenditures:

The 2024 budget for the Wyomissing Police Department was set at \$3,685,000, however the final total expenses were \$3,270,164 a surplus of \$414,836. A significant amount of work went into carefully managing and controlling the budget, ensuring strategic decisions were made to generate this surplus.
